Dear Friends and Supporters,

Paul Newman said it best: "You can leave Camp, but Camp will never leave you." It is a sentiment that rings true for campers, volunteers, staff, and all who visit The Painted Turtle. After a Family Weekend, Summer Session, or day event, we are reminded that although we physically leave Camp, the friendships, memories, and experiences remain in our hearts well beyond the front gates, because Camp is where you are.

Paul's words resonated even more deeply during 2020, when we were all caught in the throes of a pandemic, and The Painted Turtle was prohibited from delivering Camp onsite and in-person. Staff adapted quickly and exhibited high levels of perseverance, resilience, and creativity – just like we see in The Painted Turtle campers. Although faced with many challenges, something beautiful was born from a great deal of effort, support, and endurance: Camp-at-Home, virtual programming that brought a sense of belonging, joy, and fun into the safety of camper family homes. And while we could not physically visit hospitals through our hospital outreach program, Outpost, we shipped arts and crafts supplies and activities to our hospital and clinic partners, where Child Life professionals then assembled activity bags for safe distribution to children. We created an Outpost YouTube channel full of activities campers could do anytime, participated in virtual playroom sessions, and occasionally took over Closed Circuit TV in hospitals to share stories, play games, and facilitate crafts.



As we reflect on last year, we see that the silver linings are beautiful and bountiful. Over 15,500 children and family members were served by The Painted Turtle's programs – three times as many as in 2019. We were able to welcome families and volunteers from different states, and even different countries. We embraced technology and saw how virtual programming could become a regular part of future sessions, increasing inclusivity and our overall reach. But we were also reminded to slow down, reflect on what's most important in our lives, be compassionate, and take care of ourselves and our loved ones. We are stronger when we come together in our communities.

We could not have gotten through 2020 without the support of you, our Camp community. We are so appreciative of your flexibility, patience, and most of all, your unwavering commitment to the power of Camp even when things looked new and different. There will always be uncertainty in life, but please know this: Camp is always where you are.



Program Feature: **Camp at Home**

On March 31st of 2020, The Painted Turtle officially announced the suspension of onsite programs based on the recommendation of the CDC and Los Angeles County Department of Public Health. Knowing that the Camp community needed connection and respite more than ever before, The Painted Turtle staff made adjustments to continue to serve our mission and those in need by shifting to virtual programming. With the pivot to online programs, geographic barriers and capacity limits were removed, allowing campers and families far and wide to experience the joy and community of The Painted Turtle!

Camp at Home

- ♦ Three Family Weekends, six Summer Sessions, two day events, seven Free Choice programs, and seven Cabin Chats, delivering 3,394 camp experiences to children, siblings, and caregivers!
- ♦ Free Choice programs: Caregiver Café, Crafty Corner, Discovery, Fun with PUN, Movin' and Groovin', Music Mania, and Teen Lounge



ALD Family Weekend

- ♦ In May, we held our first-ever virtual Family Weekend for a new condition, Adrenoleukodystrophy (ALD), a rare, progressive, genetic disease that affects the adrenal glands and myelin of the nervous system. Full of Camp fun, this new weekend served 69 families for a total of 215 participants from different states and countries!

Campamento para Familias Family Weekend

- ♦ We held our second Campamento para Familias session virtually in the fall, serving 111 camper participants with all of the joy of Camp, conducted entirely in Spanish!



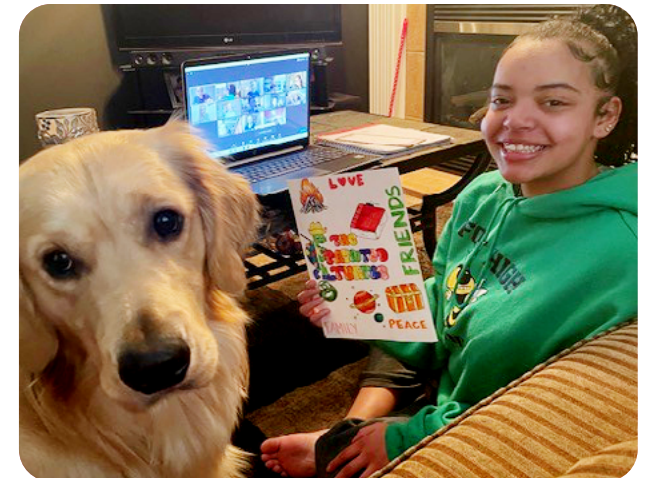
Camper Family Profile

For most of her life, Brin was generally very healthy. However, in January of 2020, her energy levels and appetite decreased abruptly and drastically. After fainting in gym class and being rushed to the hospital, Brin was diagnosed with Severe Pulmonary Arterial Hypertension, a condition where tiny blood vessels in the lungs become thickened, narrowed, blocked or destroyed, which causes an increased resistance to blood flow through the lungs resulting in higher pressures within the system.

Now age 16, Brin has endured several hospital stays and jokes that she rattles a bit when she walks because of how many pills she must take daily. Her mother, Jessica, says the time following her diagnosis has been difficult for Brin. "Her self-esteem has gone down. She is nervous to tell people about her disease because she's afraid they won't like her. She has experienced being laughed at while at school."

Amidst the medical and emotional challenges that came with Brin's diagnosis, learning about The Painted Turtle's Camp at Home program felt like a sigh of relief for the Marks family. "It was so nice to have something positive being shared with us because at the time it felt like we were only hearing sad stuff," says Jessica. The family immediately signed up for the online Pulmonary Hypertension Family Camp. They were excited to meet others who understood their history, but also a bit apprehensive. "I was really nervous because I can be shy and my self-esteem hasn't been great since I was diagnosed, so I was worried about being judged," shares Brin.

As soon as she powered up her computer for Camp at Home, her fears began to melt away. "I was amazed by how much fun I had and my cheeks hurt from smiling so much," says Brin. She began meeting other campers with pulmonary hypertension, and though they connected on their mutual diagnosis, Brin soon realized the fun of Camp shifted the focus from her illness to the joy of just being a kid. "I haven't felt that comfortable around anyone since my diagnosis – everyone was so welcoming, and no one cared about my disease."



"Fun" can't fully describe The Painted Turtle... it is over the top excitement and constant laughter," remembers Brin. Jessica agrees, "We are new to this, but we feel like we have been around forever because that's how everyone there makes you feel."

Though the Marks family currently resides in Canada, they look forward to the opportunity when they can come to Camp in person to meet other families, enjoy the activities, and dance together.

Program Feature: Outpost

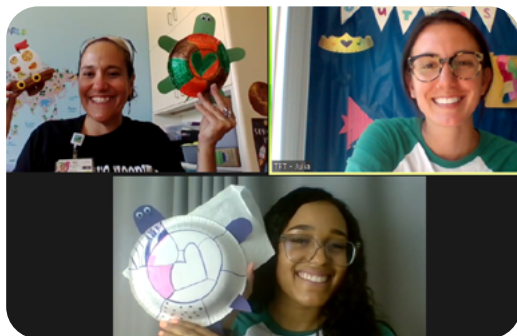
Thanks to the support of hospital Child Life Specialists, The Painted Turtle Outpost Program continued to bring the joy and wonder of Camp to 12,390 children and caregivers during their hospital stay in 2020. Outside of the initial in-person visits earlier in the year, we were also able to:

- Host 10 virtual playroom sessions, serving 67 children and teens
- Host two in-hospital Closed Caption TV shows at MemorialCare Miller Children's and Women's Hospital in Long Beach - "The Millie Show" - reaching over 65 children in their hospital rooms
- Deliver 11,653 activity bags to over 35 hospital and clinic locations throughout the state of California



Virtual Playroom Magic Moment

In October, Outpost held a Halloween themed virtual playroom with UCSF Benioff Children's Hospital Oakland. They had some familiar faces on screen, campers they had met at previous virtual playrooms, and even one they had met in person a few times during a previous hospital visit. One camper, about 11 years old, is a funny kid who tells lots of jokes and is quick with puns (he loves to throw them back and forth with longtime volunteer PUN when they're in the playroom together). He had recently lost his voice due to medical treatments, but was still sharing jokes and puns through the Zoom chat. The Outpost team told him he should host a talk show like Trevor Noah because he was so good! His response was: "But I would need my friends, you, to come so we can chat and tell jokes." The whole group was honored to hear that he considered them friends and would LOVE to be guests on his show.



Virtual playrooms offer the chance for campers to feel a part of a community, share some giggles, and have fun during their hospital stay, even though the physical playroom is closed. The Outpost team is so grateful to everyone who has supported the program during this past year, especially the Child Life Specialists who have been working hard to make sure activity bags are put together and safe for all of the campers in the hospitals during the pandemic!

Camp Updates

Diversity, Equity, Inclusion, and Sustainability (DEIS)

In June 2020, our DEIS committee convened for the first time to review and discuss opportunities on how to improve diversity, equity, inclusion, and sustainability at The Painted Turtle. In October 2020, the committee organized the first all-staff DEIS workshop focused on foundational knowledge on a wide variety of topics by Rudy Nickens, a facilitator at Evolution. The committee continues to have crucial conversations, has outlined strategic goals, and is facilitating important conversations for staff.

Campsite Improvements

The Painted Turtle campsite was bustling with activity thanks to our Operations team! A variety of projects were completed to ensure the site was ready to go for campers to return in-person. The team constructed and refurbished pathways throughout Camp, renovated the gym floor, and re-surfaced the pool. Preparations also began for the construction of a fully accessible tree house and amphitheater. Every building was cleaned top to bottom, all closets organized, several areas received a fresh coat of paint, and thanks to some beautiful landscaping, the grounds look brand new.

In addition to making sure Camp looks great, the Operations team worked hard to support sending out Camp at Home Boxes and add additional safety features including new handwashing stations, touchless hand sanitizer and soap dispensers, HEPA filters throughout Camp, as well as a stock of PPE supplies in preparation for future onsite programs.

December 1st marked the first-ever virtual special event fundraiser, Camp-A-Thon, a 24-hour campaign that took The Painted Turtle across the globe to spread awareness and raise funds crucial to Camp programming. 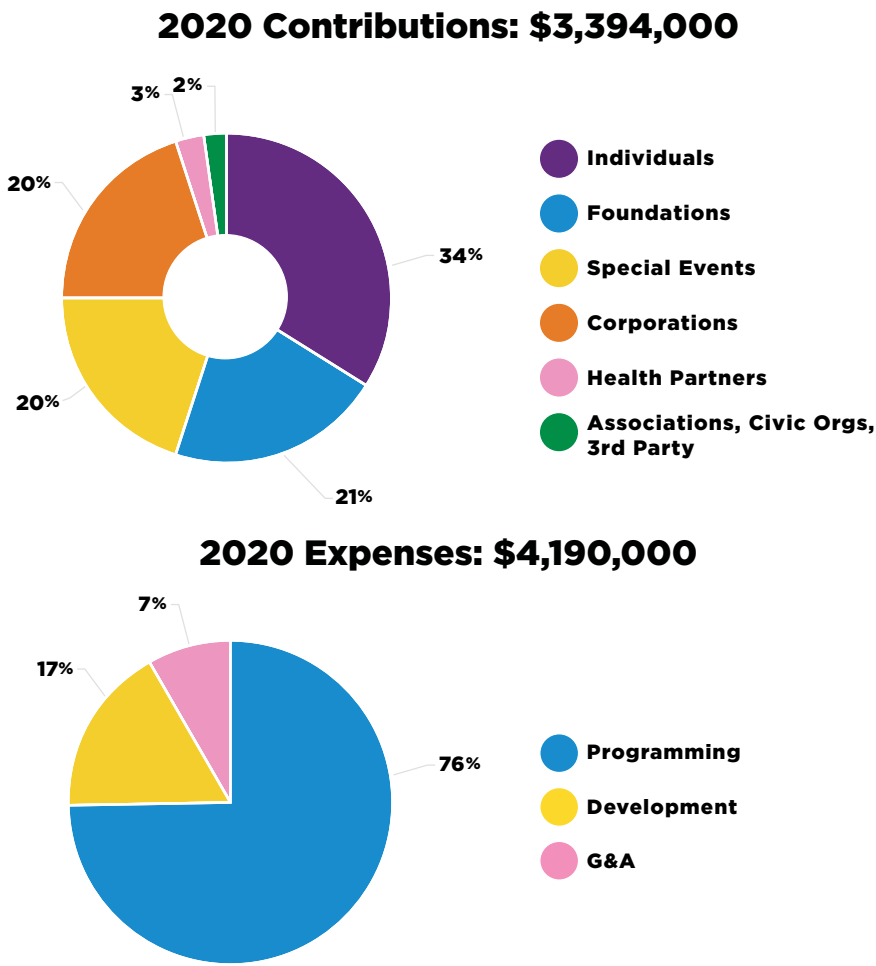

2020 Financials

The Painted Turtle is grateful to its donors and committed to showing the utmost diligence and respect for every dollar raised by ensuring the greatest possible impact on children and their families.

The cost of funds raised based on Charity Navigator’s Fundraising Efficiency calculation was 20 cents on the dollar, exceeding the standards established by organizations that monitor the work of charities.



The Painted Turtle’s fiscal year is January 1 – December 31.

Support of \$3.35 million funded fiscal year 2020 operations. An additional \$44,000 was received from capital campaign contributions. Gifts from individuals comprised 34 percent of operating contributions while corporate and foundation gifts amounted to 20 percent and 21 percent, respectively. Health Partner donations contributed 3 percent, special event donations contributed 20 percent while Associations, Civic Orgs and 3rd Parties contributed the remaining 2 percent.

Fiscal year 2020 expenses totaled \$4.19 million. Expenses for Camp programs represented 76 percent of total expenses. Included in these expenses, Camp activities, including both the Summer Sessions and Spring and Fall Family Weekends and day programming, amounted to 93 percent while the Hospital Outreach Program comprised 7 percent. Development costs represented 17 percent of total expenses, and general and administrative costs accounted for the remaining 7 percent of expenses.
