## PROGRAMS THAT CONNECTED OUR CAMP FAMILY

Our 2021 programs connected campers with serious illnesses and their families to the magic of The Painted Turtle – at Camp, at Home, in their communities, and in hospitals. We broadened our reach and inclusivity with 29,517 camp experiences rooted in our "challenge by choice" philosophy. Through empowering activities that promoted independence, built self-confidence, and connected campers and caregivers with our larger Painted Turtle family of support, our campers got to be kids when they needed it most.

## IN-PERSON CAMPER EXPERIENCES

We safely returned to in-person programs with three Family Days in the summer and a Family Overnight Retreat in the fall. Families rotated through activities that included archery, arts and crafts, discovery, fishing, swimming, and woodshop – all in a socially distanced manner.



## **ON THE MOVE CAMPER EXPERIENCES**

Camp on the Move was our innovative response to reach campers where they were and foster deeper connections. Counselors and volunteers packed up Painted Turtle vans with games, crafts, and camp spirit, taking the magic of The Painted Turtle on the road.



## AT HOME CAMPER EXPERIENCES

We expanded our virtual Camp at Home program in 2021 with two Family Weekends, six Camp at Home Summer Sessions and a Cabin Chat Series. These engaging and interactive in-home camp experiences brought the whole family together for Painted Turtle favorites like no-hands spaghetti and a virtual campfire! Who knew that online Camp could be so much fun?



## IN HOSPITAL CAMPER EXPERIENCES

Our Outpost Program delivered the joy of The Painted Turtle to 22 hospitals and clinics across California in 2021, reaching 25,757 children and caregivers. We hosted 442 virtual playroom experiences that brought the magic of The Painted Turtle to children and families during their hospital stays. We also partnered with Child Life Specialists to provide activity bag supplies.

## - The Fitzpatrick family

The Fitzpatrick family has been coming to The Painted Turtle since 2018 and has experienced nearly every program we offer. Over the years, The Painted Turtle has played an important role in their lives.

Parents Kelly and Robert Fitzpatrick have led a life of service volunteering in orphanages in China and on missions in Mexico. While in China, they served as the directors of a camp for children with special needs who do not have parents. Through this work, they met and eventually adopted their son Bryan just shy of his sixth birthday. At birth, Bryan was diagnosed with diastematomyelia. Diastematomyelia is a condition where the spinal cord is split in the lower back area. This split in the cord can cause weakness in the legs, loss of muscle strength, scoliosis, lower back pain, and difficulties with bowel and bladder control.

During his first Painted Turtle experience, Bryan fell in love with archery and reveled in the freedom to pick which activities he wanted to do. He adored his camp counselors and found joy in "potty parties" where he didn't feel embarrassed about catheterizing. The following spring, the Fitzpatricks attended a Family Weekend so they could all share in Bryan's newfound joy. They connected to a community that would help them navigate the landscape of raising and caring for a child with severe special needs and they met someone who would significantly improve Bryan's day-to-day physical struggles. During the Caregivers Support Session, Dr. Bryan Hanak, a volunteer from Loma Linda University Children's Hospital, was fielding questions about spina bifida when Kelly shared Bryan's rare situation. After the session, Dr. Hanak offered to perform a surgery to untether, (remove attachments like scar tissue) Bryan's spinal cord. This procedure can alleviate pain, restore sensation and strengthen movement in the lower extremities, which improves bowel and bladder control. Today, Bryan is completely unterhered for the first time in his life



During the pandemic, Bryan benefited from The Painted Turtle's online programming bringing him social opportunities he was missing. The Fitzpatricks also experienced Camp on the Move: Home Edition, where The Painted Turtle came to their house and set up a party on the lawn with crafts, games, and camp dances. When it came time to return in-person, Bryan was elated!

We are so fortunate to have the Fitzpatricks as part of our Painted Turtle family. Somos Familia!

We were delighted to welcome Nicole to The Painted Turtle's Board of Directors in 2021, and thanks to her leadership, Thermo Fisher provided Camp's COVID-19 testing, ultimately helping us return to onsite programs.

The Foundation officially closed its doors in 2021, but the camper joy, laughter, independence, and connections made at The Painted Turtle will only multiply in perpetuity thanks to their kindness, selflessness, and understanding of how important it is to just be a kid.

The results of a first-of-its-kind study done by American Institutes of Research revealed exactly why The Painted Turtle takes fun so seriously: because everything we do, from the environments we create to the communities we foster, has the potential to change lives.

The Lasting Impact of Camp Study included responses from more than 2,200 SeriousFun camp alumni aged 17-30 from all over the world, including nearly 200 former campers from The Painted Turtle. These campers, now adults, shared how the SeriousFun experience helped shape their lives and what elements of the experience were most influential. We are so grateful and proud that they continue to be a part of the SeriousFun and The Painted Turtle camp family!



## **2021 FINANCIALS**

The Painted Turtle is grateful to its donors and committed to showing the utmost diligence and respect for every dollar raised by ensuring the greatest possible impact on children and their families.

The cost of funds raised based on Charity Navigator's Fundraising Efficiency calculation was 17 cents on the dollar, exceeding the standards established by organizations that monitor the work of charities.

2021 Contributions: \$3,629,000

The Painted Turtle's fiscal year is January 1 - December 31.

Support of \$3.63 million funded fiscal year 2021 operations. An additional \$3.26 million was received from capital campaign contributions. Gifts from individuals comprised 41 percent of operating contributions while corporate and foundation gifts amounted to 17 percent and 23 percent, respectively. Health Partner donations contributed 2 percent, special event donations contributed 12 percent while Associations, Civic Orgs and 3rd Parties contributed the remaining 5 percent.

Fiscal year 2021 expenses totaled \$3.59 million. Expenses for Camp programs represented 76 percent of total expenses. Included in these expenses, Camp activities, including both the Summer Sessions and Spring and Fall Family Weekends and day programming, amounted to 92 percent while the Hospital Outreach Program comprised 8 percent. Development costs represented 17 percent of total expenses, and general and administrative costs accounted for the remaining 7 percent of expenses.


